**WHEREAS**, the Client desires to hire Brighton Media Productions to provide videography services as described herein, and the Production Company agrees to provide such services under the terms and conditions set forth in this Agreement;

**NOW, THEREFORE**, in consideration of the mutual covenants and promises herein contained, the parties hereto agree as follows:

**1. Services Provided**

- The Production Company agrees to provide the following videography services:

**2. Deliverables**

- The Production Company will deliver the following final products:

### 3. Fees and Payment

- The Client agrees to pay the Production Company a total fee of £**AMOUNT**
- A non-refundable deposit of 50% (£**AMOUNT**) is due upon signing this Agreement.
- Your project is not considered confirmed or booked until payment of the deposit.
- The remaining balance of £**AMOUNT** is due before delivery of the final edits of the above videos.
- Additional services requested by the Client that are not included in this Agreement will be charged at a rate of £25 per hour.

### 4. Cancellation and Refunds

- If the Client cancels the Agreement within 3 days of the event, the Client will forfeit the deposit.
- If the Production Company cancels the Agreement for any reason, the Production Company will refund all payments made by the Client, including the deposit.

### 5. Responsibilities

- The Client agrees to provide a suitable venue or location and any necessary permissions for the Production Company to perform the services.
- The Production Company agrees to perform the services in a professional manner and to the best of their ability.

### 6. Ownership and Rights

- The Production Company retains all copyright and intellectual property rights to the footage and final videos produced.
- The Client is granted a non-exclusive, non-transferable license to use the final videos for personal or commercial purposes as specified in the Licensing Agreement.
- The Client agrees not to alter, edit, modify or resell the final videos without the Production Company written consent.

### 7. Confidentiality

- The Production Company agrees to keep all information related to the Client's event confidential and will not disclose any such information to any third party without the Client's consent.

### 8. Limitation of Liability

- The Production Company's liability for any claims arising under this Agreement shall be limited to the amount paid by the Client to the Videographer.
- The Videographer shall not be liable for any indirect, incidental, or consequential damages arising out of or related to the services provided under this Agreement.



## **9. Governing Law**

- This Agreement shall be governed by and construed in accordance with the laws of England and Wales.

## **10. Dispute Resolution**

- Any disputes arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of England and Wales.

## **11. Entire Agreement**

- This Agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior agreements, whether written or oral, relating to such subject matter.

## **12. Amendments**

- This Agreement may not be amended or modified except in writing signed by both parties.

## **13. Severability**

- If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

## **14. Notices**

- Any notices required or permitted to be given under this Agreement shall be in writing and sent to the addresses provided above.
